Sir,

As per endorsement, I have visited the spot i.e. Hotel Element, Mantripukhri near UCO Bank and conducted inquiry. Upon inquiry, the lone staff and incharge of the hotel namely Maisikam Zuinamai (21) yrs S/O Genglungbou Zuinamai of Chaton Part I Village, Tamei, Tamenglong District stated that on 22/08/2023 at around 12:40 am, 4 (four) persons including a woman came to the hotel and one of them called RK Tomba asked the incharge if Soketis and two others by the name Thethe and Pilu were available at the hotel. Whereas none of them was present at the hotel at that time. He, then, told him to call Soketis on phone but his phone was found switched off. Soon after they started vandalizing properties of the hotel such as Smart T.V., speaker, flower vase etc.

Further, no other person who witnessed the incident could be found as it happened in the wee hours of the night and the CCTV Camera installed at the reception of the hotel was also found defunct.

I, therefore, submit the report for further necessary action.
