Subject: - Report.

Sir,

I have to report that today i.e. the 28<sup>th</sup> August, 2023 at about 3:00 p.m. received a reliable information about the presence of some anti-social elements in and around Mongjam, Imphal-East. Based on the said information, teams of CDO/IE and Heingang Police Station led by Inspt. Kh. Henery Singh OC-CDO/IE and Inspt. Kh. Pathou Singh, OC-HNG/PS, Imphal –East District assisted by Hav. OT11001 Kulabidhu Soibam of MPTC presently attached with CDO/IE Unit rushed to the said area and conducted a searched operation in and around Mongjam Mayai Leikai, Imphal-East.

In that, one suspected car (Hyundai i20), red in colour was detained at Mongjam Mayai Leikai at 3:45 p.m. On verification, the driver of the car identified himself as one **Longjam Naoba Singh, aged about 31 years, S/o (Late) L. Naba Singh of Moidangpok Khullen Mamang Leikai, Patsoi PS, Imphal-West District** and the occupant identified himself as one **Huiningshubam Kenjen Singh @ Kengba, aged about 35 years, S/o H. Ibomcha Singh of Awang Khunou Mayai Leikai, Patsoi PS, Imphal-West District**. On checking the driver of the car (Naoba), one mobile phone and one wallet were found and recovered from his possession. On checking the occupant of the car (Kenjen) two nos. of mobile phones and one wallet card were found and recovered.

On further verification, both the detainees (Naoba and Kenjen) stated that they are active members of the outfit KCP (Lamyamba Khuman) joined through one Mr. Kiran of KCP (Lamyamba Khuman) about a month before. They further stated that, on the advice of the said Mr. Kiran of KCP (Lamyamba Khuman) today they came to extort money from the Oil Pumps and Brick Fields located at Koirengei, Awang Potshangbam and Mongjam area of Imphal East District for raising their party fund. So, both the detainees were arrested from the spot i.e. Mongjam Mayai Leikai near Community Hall at 4:20 p.m. by observing due formalities. One car (Hyundai i20), red in colour, bearing regd. no. WB-16 AM/1455 (without registration no. plate), one mobile phone (Redmi 8A) bearing IMEI no. 860902059364790 & 860902059364808 along with one Airtel SIM card bearing no. 8991160990010158029U and one wallet containing a sum of Rs. 530/- (five hundred and thirty) and one PAN card were seized from the possession of the arrestee Longjam Naoba Singh at 4:40 p.m. at Mongjam Mayai Leikai near Community Hall by observing necessary formalities. One mobile phone (Nokia TA 1423) bearing IMEI no. 350138384138791 along with one Airtel SIM card bearing no. 8991160990021670513U, one mobile phone (Redmi 10 Prime) bearing IMEI no. 869598050805491 & 869598050805509 along with one Airtel SIM card bearing no. 89918650500010722550 and one wallet containing a sum of Rs. 650/- (six hundred and fifty) and one AADHAR card were seized from the possession of the arrestee Huiningshubam Kenjen Singh at 4:50 p.m. at Mongjam Mayai Leikai near Community Hall by observing necessary formalities.

Therefore, the arrested persons along with the seized items were handed over to you for taking up further necessary legal procedures against them.
