Sir,

With due respect, I have the honour to report that today i.e 28/08/2023 based on the general input conducted cordon and search operation (CASO) from 3:30 pm to 5:45 pm by a combined team comprising 7 (seven) CDO teams of Imphal East led by Addl. SP. Ops I/E Shri Kh. Herojit, MPS, a team of HNG-PS led by ASI Y. Johny Singh, a team of 4th Assam Rifles along with a team of 16 JAT Regiment under the overall Supervision of Shri Ksh. Shivakanta Singh IPS, SP/IE in the general area of Pangei Nepali Basti.

In that about 40 (forty) nos. of houses were searched and occupants of the houses verified. Further during the operation received credible input about presence of some illegal arms hidden at the foot hill of Marjing Hill in which four (4 team) rushed to the said area and searched the suspected area and found one yellow bag kept hidden at the foot hill. On checking the yellow bag found the undernoted arms abandoned. Therefore, the abandoned arms were seized after preparing a formal seizure memo at 05:30 p.m.
