That, I would like to inform and register a cognizable offence carried against me and my family at our owned house located at Molnomphai, Kangpokpi District. P.S. Saikut Yaingangpaket

That, on the 28th of May, 2023 at around 6:00 AM, a huge contingent of armed radical Meeitei/Meitei suspected to be members of the Arambai Tengol and Meetei Leepun attacked our locality and in the process burnt down our house along with all the properties.

That, it may be reported here that above said criminal activities have caused grave mental agony and incurred huge loss which may be estimated (approx.) to be Rs 35,00,000 /-(Rupees Thirty five Lakhs) only.

Fortunately, me and my family managed to escaped from these criminals who even tried to kill or burn us alive, and now currently taking refuge at Taitah Kaprang, P.O. & P.S. Churachandpur, Dist. Churachandpur, Manipur.

I am filing this report lately since I have been at different places for safety. Now, since I am able to settle myself at the above mentioned address, I am in a position to file a report today. Hence, prayed that my report be accepted.

In the given circumstances, I humbly pray you to kindly register a ZERO FIR, investigate the matter and punish the perpetrators as per the prevailing provisions of the laws of the land. And, for which act of kindness, I shall always remain thankful to you and obliged.
