Madam,

With reference to the above cited subject, I have the honor to report to you as below:

1. That, I Thanglu Baite age 46 s/o Yamthong Baite

belongs to the Khamti Community, a Schedule Tribe recognized under the Constitution of India. By Virtue of which I am entitled for protection under The SC/ST (Prevention of Atrocities) Act, 1989. Whereby, I am a permanent resident of Twichin P.S. Yaingangkopi District Kangpokpi

2. That, on 4th Aug 2023 at 4 AM/PM, a huge contingent of armed Radical Meeitei/Meitei Mobs, Arambai Tengoi and Meeitei Leepun along with State Forces like Manipur Police Commando and Indian Reserve Battalion (IRB) attacked our village, and in the process looted/vandalized/burnt my house/properties.

3. That, the above said Criminals with their inhumane activities have grave caused me grave mental agony. Notwithstanding the fact that, their unruly activities have made me loss enormous wealth estimated to be Rs 18,00000 (Eighteen lakhs) Only

4. Fortunately, me and my family narrowly escaped from these Criminals who even tried to kill us.

Henceforth, we are taking refuge at K. Khomunnom Relief Centre, Acpur

I, therefore, request you to register an FIR/ZERO FIR and bring justice.
