I have the honour to State that, on date 31/05/2023 at around 10:00 Pm some unknown miscreants suspected to be a members of Meltel youth Organisation such as Meltel Leepun, linguage pakes retire in the Stangleipak kanba lup (KKL), Arambai Tenggol and Women wings, World Meltel Council (WMC), Schedule Tribes Demand Committee (STDC), Manipur Police Commande and Oinam Akash OC – Incharge AR Sagolmang, combining local peoples from Sekta, Lousangkhong, Kelbi komuda, Teretkhul, Lambolkhul, Uyumpok, Pakhao, Kelbi Khullen, Helkak mapal, Tiger camp and Lamlai, Yalngangpokpi as numbering about 1500 – 5000 persons carrying Sophisticated weapons like AK, SLR, INSAS and 303 rifles, forcefully entered our village, Phaimol Village, having 30 houses, under Saikal Sub – Division, Kangpokpi District, Manipur about 24 Km South East from Saikal Police Station.

After looting all the moveable properties including Domestic animals and cattle's they vandalised and burn down all our houses including Church and Church Properties, Church office, School, Anganwadi Centre, Community Hall, Granaries, Vehicles, including all the household properties to the ground leaving all of us homeless. The approximate value of properties destroyed estimate calculated at about Rs. 38, 00,00,000 (Thirty eight crores)

It is therefore, requested you to kindly register a regular case and take necessary legal action against the culprits according to Law.
