Sub: Report of criminal intimidation and un-lawful displacement. Mamur

Sir,

I, the undersigned would like to bring forth to your knowledge and report that I am a permanent residence and native of N. Mothoi Phai Village, P.O.&P.S. Yaingyapokpi/Lamlae District Kongpokpi Manipur and that because of the communal clash between the Meitei and The Hill Tribal tension arouse since 3<sup>rd</sup> May 2023. Since then various arms intimidation and attempt have been made to burn down our village by the majority Meitei mob armed with fire weapons, sword and stick which create a sense of insecurity and fear for safety to our own life and property with no means of defenses and security from the government makes our village un inhabitable. As such, I along with my family member are forced to move to a safer place facing all difficulties and leaving behind my house and property to take refuge at UPC Church, Tui bong Churachandpur, P.O.&P.S. Churachandpur set up by KKL (a philanthropies organization) due to this crises.

I therefore, pray that you may kindly take appropriate action so that I may return to my native village with sense of security and peace or rehabilitate us to safer place at the earliest.
