Trouble started from 3/5/2023 onwards when armed Kuki militants came down from the hills and fired several rounds of gunshots. We became apprehensive as we also heard that violence started between Kukis and Meikis in other parts of the state too. Early morning on 4/5/2023, we fled our village and reached Yonabung where we have been staying since then.
