**Subject:- Report on Crimes of Vandalism, Looting and Arson of Properties and Discrimination of Schedule Tribes**

Respected Madam,

With reference to the above cited subject, I have the honour to report to your good office as follows:

That, I, Haongam Touthang aged about 24 years S/o Sojam Touthang belonging to the Any Kuki tribe/community, a Schedule Tribe recognized under the Constitution of India, by virtue of which I am being entitled to the protection under The SC/ST (Prevention of Atrocities) Act, 1989.

That, I would like to inform and register a cognizable offence carried against me and my family at our owned house located at Twichim Village, Chingdai Khullen, Kangpokpi District. P.S - Saikul.

That, on the 28<sup>th</sup> May, 2023 at around 7:30 PM, a huge contingent of armed radical Meeitei/Meitei suspected to be members of the Arambai Tenggol and Meetei/ Meitei Leepun attacked our village and in the process vandalised, looted and burnt down our house along with all the properties.

That, it may be reported here that above said criminal activities have caused grave mental agony and incurred huge loss which may be estimated (approx.) to be Rs 50,00,000 /-(Rupees Fifty Lakh) only.

Fortunately, me and my family managed to escaped from these criminals who even tried to kill and now currently taking refuge at Khonom Village, Sangaikot, Churachandpur District, Manipur.

I am filing this report lately since I have been at different places for safety. Now, since I am able to settle myself at the above mentioned address, I am in a position to file a report today. Hence, prayed that my report be accepted.

In the given circumstances, I humbly pray you to kindly register a **ZERO FIR**, investigate the matter and punish the perpetrators as per the prevailing provisions of the laws of the land. And, for which act of kindness, I shall always remain thankful to you and obliged.
