
Sir,

I have the honour to state that, on 5<sup>th</sup> May, 2023 at around 2:30pm some unknown miscreants belonging to Meitei/Meetei youth of Arambai Tenggol, World Meitei Council(WMC), Meitei Leepun and Kangleipak Kanba Lup (KKL) numbering about 900-1000 members carrying sophisticated weapons like AK Rifles, SLR and .303 Rifles forcefully entered in my Village, Kamu Themdoi, P.O. - Yairipok, P.S. - Maphou, Island Sub-Division, Kangpokpi District, Manipur having around 30 houses, after looting all the valuable household properties, has been burnt down. Apart from the house some important building like Church, Prayer Hall, School Building, Hostel and Boarding Building, Toilet Complex, Grocery Shops, Granaries, Cattle sheds, two wheelers- 3 were totally burnt down. Many livestock's were also burnt and killed.

The Approximate value of lost properties is estimated to be about Rs. 60-70 crores.

It is therefore, requested to kindly take necessary legal action and booked the culprits according to law.
