Total number of person were 4 (four) wearing black dresses along with 3(three) AK 47 and a Pistol. The Colour of the Van is blue in colour with no number plate. Later it was found that the Vehicle was seen heading towards the Salan thong Bridge with the help of CCTV Camera.

I, therefore request you to kindly arrest the culprits in favour of justice.
