In that workshop, two workers are kept for making jewelleries namely (1) Mr. Tulasi Samanta (35) yrs S/O Bhabani Samanta of Kultikri-Ghatal, Paschim Medinipur, PS-Daspur, Daspur-II, West Bengal, Pin-721153, Ph. No. 8918589265 AND (2) Mr. Shiv Sankar Samanta (30) S/O Kinkar Samanta of Kultikri-ghatal, Paschim Medinipur, PS-Baspur, Daspur-II, West Bengal, Pin-721153 Ph. No. 8597677953. As they are hired from Kolkata after contacting one Mr. Tara Sankar Samanta (35) yrs S/O Kinkar Samanta of Kultikri-ghatal, Paschim Medinipur, PS-Daspur, Daspur-II, West Bengal, Pin-721153 Ph. No. 7501297482 and they are the cousin brothers.

On 11/09/2023 at around 05:00 pm, I came to known that Mr. Shiv Sankar Samanta has stolen 270 gm. Of Jewelleries which may worst Rs. 16.2 Lakhs and 50,000/- cash from the workshop and left Imphal. There is a high possibility that all the three brothers are involved in this crime.

It is therefore requested to arrest all the culprits who were involved in this crime for taking further necessary legal action against them.
