Sir,

With due respect, the undersigned, would like to humbly request your good self for taking up necessary legal actions against the culprit(s) on the ground as mentioned hereunder.

It is started that my father died on 05/10/2023 and the ritual ceremonies including Sharda Ceremony (18/10/2023) were performed at my parental home at Thangmeiband Yumnam Leikai and as such my entire family were residing at the said place engaging for the ritual ceremonies. However, on 20/10/2023 at about 8 am while I returned from Thangmeiband Yumnam Leikai to my residence located at Laiphom Khunou, in the northern side of E.K. Higher Secondary School, Imphal East, it was found that some properties belonging to me namely (1) One laptop (Sony Vaio), black in colour, (2) Two numbers of cooking gas cylinder (filled) (3) One digital camera, silver and black colour of sony company (4) Music system tower speaker (Bluetooth), Glider company and (5) Water taps 10(ten) in numbers were found lost from the premises of my residence. The incident was happen while I along with my family members were residing at Thangmeiband at the said incident might be happening in between 15/10/2023 and 20/10/2023.

I, therefore, request your good self to take necessary legal actions against the culprit(s) for the ends of justice.
