Subject: Report

Sir,

I have the honour to state that, on 5th May, 2023 at around 3:30pm some unknown miscreants belonging to Meitei/Meetei youth of Arambai Tenggol, World Meitei Council(WMC), Meitei Leepun and Kangleipak Kanba Lup (KKL) numbering about 900-1000 members carrying sophisticated weapons like AK Rifles, SLR and .303 Rifles forcefully entered in my Village, K. Nungmanbi, P.O. – Yairipok, P.S. – Maphou, Island Sub-Division, Kangpokpi District, Manipur having around 24 houses, after looting all the valuable household properties, has been burnt down. Apart from the house some important building like Church, Church office, Primary School, NGO Home, Graneries were totally burnt down. Some livestock's were also burn down and lost.

The Approximate value of lost properties is estimated to be about Rs. 10-15 crores.

It is therefore, requested to kindly take necessary legal action and booked the culprits according to law.
