Sir,

I have the honour to state that on 28/09/2023 at around 6:30 pm. some unknown miscreants suspected to be members of Meitei Youth Organisations, Hutei Lup kanglipak kanba Lup (KKL), Ahombei Tenggol and World Meitei Council (WMC). Schedule Tribe Demand Committee (ST) numbering about 1500-2000 persons carrying sophisticated weapon like Ak Rifles, SLR, INSAS and .303 Rifles forcibly entered our village under Saikul sub division, Kangpokpi District, Manipur about 30km East from Saikul PS and they vandalised my house and looted all the moveable and valuable properties buried down my house along with all the remaining items in ashes leaving us homeless.

The list of properties destroyed or loss are mentioned in the Annexure (enclosed). The approximate value of destroyed or loss properties is calculated at about 1517200/- (one five one seven two zero zero).

It is, therefore requested you to kindly register a regular case and take necessary action against the culprits according to law.
