With most respect, I stated that the following lines for your kind consideration and necessary action.

That on 23th October, 2023 at around 11:30 pm, some unknown persons around 10 with full arms wearing black dresses intrude into office premises and start snatching personal phone and make false allegation the Vertigromt Pvt. Ltd situated at Kairang. Moreover the unidentified were fully drunk and start assault and also make gun point to staff and beating black and blue.

The following items are looted i.e. (1) one Breeza bearing Registration No. MN06LA2938 silver in colour (2) one Swift car bearing Registration No. MN06LB8404 grey in colour (3) 21 (twenty one) personal phones, (4) one Laptop and (5) Rs. 4000/- in cash along with DL, RC and Adhaar Card. Secondly, they call from phone number 9233128528 at 24th October, 2023 at 10:30 am to house care taker David and demanding a ransom of Rs 15 lakhs and to pay at 03:00 pm on the same day.
