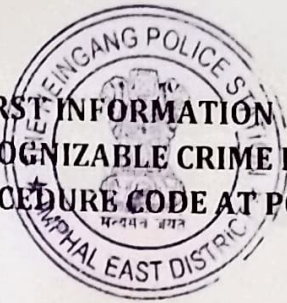

With due respect, I the undersigned have the honour to state that on 27/10/2023 at around 05:30 am, Driver Bimal Pradhan (driver of vehicle Ashok Leyland bearing registration No. WB11F4333 hired by East India Transport Agency) informed me that he along with the vehicle Ashok Leyland went for unload the goods loaded with 155 Nos. of mixed goods under Manifest No. GHB0208061 which was dispatched from Guwahati to Imphal, dtd. 24/10/2023 at the godown located at Koirengei, Nilakuthi.
