Sir,

I have the honour to state that, on 30-05-2023 at around 07:00 am some unknown miscreants suspected to be a members of Meitei Youth Organisations, Meeteis Leepun, Kangleipak Kanba Lup (KKL), Arambai Tenggol and World Meitei Council (WMC), Schedule Tribe Demand Committee (STDC) numbering about 1000-1500 persons carrying sophisticated weapons like AK Rifles, SLR, INSAS and .303 Rifles, forcefully entered our village, Urangpat Village under Lungtin Sub-Division, Kangpokpi district, Manipur. They vandalized my house and looted all the moveable properties including the domestic animals and burnt down my house along with all the remaining items into ashes leaving us homeless. Fearing lost of live, me and my family left our home and fled to the jungle and hide the whole night without food, water and blanket and as of now we temporarily stayed at Zalenbung Relief Centre, Ukhrul district, Manipur.

The list of properties destroyed or loss are mentioned in the annexure (enclosed).
The Approximate value of destroyed or loss properties is calculated at about
Rs.10,000,00/-.

It is therefore, requested you to kindly register a regular case and take necessary legal action against the culprits according to law.
