Phaimol Village, near Yaingangpokpi, Lhungtin Sub-Division, Kangpokpi District, burnt down my house and vandalised all my movable and immovable properties of the same day.

The Approximate total cost of my property items worth is Rs 20 lakhs (Twenty Lakhs only).

It is therefore, submitted & request you to process my FIR complaint in connection with this incident.
