Subject:- Report

Sir,

With due respect, I have the honour to report that today i.e. 6/11/2023, at about 6:00 am teams of CDO Imphal East Unit along with woman Police ersonnel conducted a search operation at Khundrakpam Mayai Leikai, Imphal East District and its surrounding areas under the command of Shri Kh. Herojit Singh , MPS Addl SP(Ops) Imphal East District and under the overall supervision of Shri Dr. S. Ibomcha Singh MPS, Superintendent of Police Imphal East District.

In the search operation, the CDO teams along with the woman police personnel searched about 70 houses and occupants of those houses were verified. During that, I along with my team spotted some suspected items buried under the surface near a crematorium, opposite to YLL Club, Khundrakpam Mayai Leikai, Imphal East District. The team dig out and found three nos. of iron boxes suspected to be arms and ammunitions carrier box. On opening the iron boxes there found the undernoted arms, ammunitions, magazines, anti riot shell, explosives etc. containing inside the iron boxes.

List of the items:-

1. 1(one) no. of SMG Carbine B/Regd. No. RR 6960, SAF 1972 along with three magazine
2. 1(One) no. of 36 Hand Grenade with ring,
3. 1(one) no. of tube launching
4. 16 (sixteen) nos. of INSAS LMG Magazines
5. 4 (four) nos. of INSAS rifle gas Cylinder cape,
6. 7(seven) nos. of 7.62 SLR ammunitions Charger Clips,
7. 62 (sixty two) nos. of .38 ammunitions
8. 3 (three) nos. of empty ammnutions carry box and
9. 6 (six) nos. of anti riot cell.

Thereafter, the above recovered arms, ammunitions, explosives, magazines, anti riot shell etc. were seized from the spot i.e. near the crematorium, opposite to YLL Club, Khundrakpam Mayai Leikai, Imphal East District at 7:10 am by observing due formalities.

Therefore, the seized items are being handed over to you for taking up further necessary legal procedures.
