With due respect and humble submission, I would like to file a complaint against vandalization of my house and properties looted on the 4<sup>th</sup> May, 2023. On that dreadful day my house which is located at Jangnomphai Village, Lungtin Block, Kangpokpi District, Manipur, was vandalized and many properties including some crucial files have been looted and destroyed by the Meitei community.

The following items of properties looted and lost are as follow.

1. Household items: Washing Machine, Refrigerator, TV.
2. Furniture: Dressing tables, almirah, Dining table, Beds.
3. Others movable and immovable assets.

The approximate value of lost/ destroyed and looted properties is estimated to be about Rs. 10,00,000/-

Therefore, I kindly request you to take necessary action according to the law in this regard.
