Today i.e. 12/10/2023 at @ 7:10 pm received a reliable information that on the same day at around 03.05 am some unknown miscreants were firing 20/25 rounds of automatic weapon at Molnomphal, Twichin (Sangran) hill range near by Sabungkhok Khunou brick field hill range by some suspected unknown armed Kukis with an intention to cause injury/damaged/death to the nearby Meitei villagers. In the morning at around 08:40 am the firing was again started from the Molnomphal and Twichin (Sangran) hill range. The continuing of firing was in between Molnomphal and Twichin (Sangran) hill range and nearby Sabungkhok Khunou brick field hill range. It was suspected to be in between armed Kukis and Meiteis/Meeteis village volunteers. The state security personnel of OC/YPI-PS, Addl-SP(OPs) IE, SDPO-LLI, and SDPO Chingai (camp YPI-PS), OC/LLI-PS and CAPF, Army intervene and controlled the situation. The firing lasted till 06:00 pm. It was learnt that some persons were injured in the incidents.

In this regard the OC/YPI-PS registered a suo-motto case under FIR No. 304(10)2023 YPI-PS, U/S 307/338/503/34 IPC & 25 (1-C) A. Act.
