Sir,

With due regard, I the undersigned have the honour to report that on 16/11/2023 at 03:00 pm, my cousin brother namely Laishram Kiran Singh aged about 40 yrs S/o (L) L. Jatra Singh of Kontha Ahallup Maning Leikai, IE along with two of his friends namely Laishram Mukta Singh (37) Yrs S/o L. Tomba Singh of Kontha Ahallup Maning Leikai, IE & Haorangbam Romen Singh (43) Yrs S/o H. Ibocha Singh of Kontha Ahallup Maning Leikai, IE went to Pangei. Later Mr. Laishram Mukta Singh informed to his sister at 11:30 pm stating that my cousin brother namely Laishram Kiran Singh was kidnapped by some unknown persons coming in a white Maruti Gypsy B/No. not known holding guns/arms from Pangei bazar at around 08:00pm of 16/11/2023, and further stated that my cousin brother namely Laishram Kiran Singh was found under unconscious state at Heingang Khong, IE on the road side at around 11:00 pm of 16/11/2023.

Thereby, our family members rushed to Heingang Khong and we brought him at home at 03:00 am of 17/11/2023, and later evacuated him to RIMS Hospital. Lamphel and Doctor declared him brought death.

Its is therefore requested that kindly to take necessary legal action against the unknown culprit at the earlier.
