



With due regard, I the undersigned have the honour to state that on 11/11/2023 at around 05:00 pm, my husband namely RK Bishorjit Singh aged about 50 yrs S/o RK Sanatombi Singh of Seijang Mayai Leikai A/p Khabeisoi near Oil Pump, IE was dashed by one Honda Activa B/No. not known, while he was trying to cross the road at Khabeisoi opposite Oil Pump and my husband got injury on his person. Later he was evacuated to Hospital by the family members and the rider of Honda Activa namely Mr. Ngangom Nanao (50) Yrs S/o not known of Mana Ingkhol Tejpur, IE at Raj Medicity Hospital, North AOC and he bear some finical assistant to our family for medical treatment of my husband. And on 18/11/2023 while I try to call his Mobile No. 8837037963 and found swift off till date and I went to his residence at Mana Ingkho, Tejpur and found his house under lock.
