Sir, I have the honour to state that, on 5<sup>th</sup> May 2023  
a group of Arambai Teyol Volunteers numbering about  
more than one thousand Volunteers attacked Bongbalkolen  
Village with sophisticated weapons at around 12:00 noon  
to 4:00 pm. P.S. Meiphou

The whole village was demolished and ransacked  
by the attackers. A total number of 160 (one  
hundred and sixty) houses has been burnt  
down with all village assets and properties including  
BBC church, Community hall, youth club hall, school  
buildings and domestic animals.

Besides on Maruti alto car bearing NO. ML10BS663  
6 Bikes ① NO. MN01U1412, ② MN02A-2858 ③ AS10AT7115  
④ MN06925L ⑤ MN01AM3783 ⑥ MK10FD4118,  
3. Rice mills, 9-water pump sets, and all business  
establishments including household properties were  
totally demolished and looted, Village granary huts  
are looted and Confiscated.

The estimated loss of the village is approximately  
50-70 Crores. The matter may please be considered  
for necessary action in public interest.
