Sir, I the undersigned, chief of B. Geljang Village under
Island Block/Sub-Division, P.S. Mapheh, Kangpokpi district
of Manipur have the honour to state the following lines
for your kind consideration and necessary action.

That, on 5th May, 2023 at around 10:30 a.m., un-
known miscreants suspected to be a members of
Arambae Tengol, Kangliepak Kanba Lup (KKL), Mike
Reepun etc. numbering about 500-1000 attacked
us and burnt down my entire village num-
bering 25 (twenty five) houses. All the properties
such as Rice/paddy, Houses, furnitures, clothes,
traditional attires, utensils, animals, important
documents of village, church, certificates of educa-
tional institution of students and valuable assets/
goods are burnt into ashes by the attackers.

In this regard, I could not report the incident
to my concerned police station in time due to
prevailing law and order situation in the state.

I would therefore, request your good office
kindly to take up further necessary action in
this regard for which I shall remain ever
indebted to you.

The total value of the damaged/destroyed/loss
property(s) is estimated to be about 90 (Ninety Lakhs)
