Sir, I have the honour to state that, on the midnight of 3rd May 2023, at around 6:00 pm some unknown miscreants belonging to Meitei Youth Organisation suspected to be members of Atambai Tamgol who are loyal group to the present Inner MP, Shri Leishamba Sanaynoba, World Meitei Council (WMC), Meitei Leepul and Kangleipak Kauka Lup (KKL) and Scheduled Tribe Demand Committee (STDc) numbering about 1000 members attacked my village of K. Nungmanki village, Kangpokpi District, They looted all valuables and vandalized my house and stole my vehicles swoty bearing number MN06SF 8991. The approximate value of lost and destroyed properties to be about 25 lakhs.

If it therefore, requested to kindly register a regular case and take necessary legal action according to law.
