Sir,

I, the undersigned, Chief of B. Seigaland Village under Island Block/Sub-Division, P.S. Maphoe, Kangpokpi District, Manipur have the honour to state the following few words for your kind perusal and necessary action.

That, on 5th May, 2023 at around 11:00 a.m., unknown miscreants suspected to be Arambae Tingol, Kangpokpi Kanba Lup, Meitei Keipun numbering about 500-1000 members attacked us and burnt down 8 (eight) houses, Rice/paddy, furnitures, church, clothes, traditional items, utensils, other valuable goods/assets, important documents of both Village & Church and also students by the attackers. The total value of damaged/burnt down properties is estimated to be about 50 (fifty) Lakhs.

I could not report the incident to my concerned Police Station due to prevailing law and order situation in the state.

Therefore, I would request your good office kindly take up necessary action in this regard in public interest.
