I have the honour to state that, on the midnight of  
3rd May, 2023, at around 7:00 PM, some unknown miscreants  
belonging to Meitei Youth Organisation suspected to be  
members of Akambai Tengsol who are loyal group to the  
present Inner MP, Shri Leishemba Sarajaocha, Ward Meitei  
Council (WMC), Meitei Deepul and Kanglipak Kanba Kup (KKL)  
and Scheduled Tribe Demand Committee (STDC) numbering  
about 1000 members attacked my Village at K. Nungmanbi,  
Kangpokpi. They looted all valuables and vandalized my house.  
And they even stole my vehicles Ecco van bearing number  
MN06LB 8069, and two scooty activa bearing number  
MN01F 2865 and MN06S 4065.

The approximate value of lost and destroyed properties and  
vehicles stolen to be about 30 lakhs.

It is therefore, requested to kindly registered a  
regular case and take necessary legal action according  
to law.
