Sir,


With due respect I beg to state that on 15/06/2023 at around 9.20 pm one of my labour barack which is inside my brick field located at Sabungkhok Khaman Maing Leikai (chingya/foot hill) was burnt down by some unknown miscreants suspected to be armed Kuki militants by firing 3/4 rounds. In the incident some household items were burnt down moreover some chicken, goats and movable items were carried by the culprits, we all fled from the brick field because of fear.

So, I therefore request to kindly investigate about the matter and well to lodge FIR for further Justice
