Today, i.e on 05/06/2023 at 10:30 PM, I received an information that on the same day at around 3:30 am to 4: 30 am a gang of valley unknown youths (Meitei) numbering about 90 to 100 persons with holding deadly weapons like iron rod, arms etc. suddenly attacked to B. Gamnom, K. Hengjang and NP Khollen Village under KPI-Dist. dominated by Kuki Schedule Tribe consisting about 70 (seventy) houses in which all the houses including one Church of NP Khollen were burnt down and gutted into fire and looted some properties of household items.

After commission of the crime all the culprit disappeared to unknown direction.

Hence, a regular case on Suo-moto was registered under FIR No. 59(6)2023 TBL-DAM-PS U/S 147/148/149/427/400/435/447/397/34 IPC & 25(1-C)A. Act.
