There were also firing of several rounds of gunfire in the nearby villages. being attacked by armed Zeki militants. Fearing for our lives, our family abandoned our house and came to Nongdawn on 4/5/2023 in a vehicle. My husband and son stayed back to stand guard over the village. We have been taking shelter here since then.
