Sir,

On the fateful day of 30th May, 2023, around 07:00 AM, thousands of youth suspected to be 'Arambai Tenggol' group from the Meitei community along with Meitei militant, carried sophisticated guns, ammunitions and other deadly weapons, attacked my village Molkolbung Village, Saikul Sub-division, Kangpokpi District, Manipur. We fled and hid in dense forest to save our life. They had destroyed every locked doors, looted every pieces of our properties, beside, they destroyed/open my locked doors too and looted everything and also burnt down to ashes.

Details looted/destroyed items:

Residential House, Tractor Engine No. EICHER368, Traseuu (Harvesting machine), Kamco (Paddy cutter), Beds, almirahs (wood & steel), sofa set, dying set, bench, TV set, washing machine, gas cylinder, gas stove, paddy rice-150 bags, cash 3 lakhs, refrigerator, pucca toilet & bathroom, kitchen wares, syntax 500, common room table, piggery-3, mattress, blanket, inverter with battery, documents, gas box, car wash machine, tulu etc.

All valuable/invaluable items in the households were completely destroyed.

The approximate value of total losses in ₹ 17,00,000/- (Rupees Seventeen lakhs)

I therefore request to booked the culprit and take necessary action as per the law of the land.
