Sir,

I am to report that on 20th June, 2023 at about 09:00 a.m. a joint operation was conducted under the supervision of Shri Th. Sudhir Singh Dy. SP (CDO- IE) along with a team of Thoubal Dam PS at Saichang and Bongyang village on that operation we found three suspected bomb fitted in a pipe tube lying at the border area of the said place suspected to be place and plan by kuki militants. After that I informed to my superior officer and on their instruction we cordoned the areas . And at around 12.10 pm a team of CID Tech/ SBDDS arrived at the spot and after some verification and checking by the SBDDS team the suspected pipe bomb was disposed by the expert team at around 12:30 pm.

There are no casualties on our CDO teams/personnel. Here, I am being reporting this for your kind formation and further necessary legal procedures.
