Subject : Report.

Sir,

With due regards, I beg to state that today on 03/10/2023 at about 11:00 am received a reliable information that some unknown armed miscreants have stored and hidden some arms, ammunitions and explosives in the jungle of Salampatong Village near Irong Lok for using offensive act against State Security Forces and CAPF.

On receipt of the information, Special Operation Group (SOG) Thoubal District Police along with 33 AR Somrei led by Addl. SP(Ops)/TBL assisted by OC/CDO-TBL under the supervision of SP/TBL have rushed to the spot immediately and launched a massive operation at 11:30 am by using metal detectors. On searching and found the undernoted articles i.e. (1) 1 (one) no. of Carbine bearing registration number 18494802 SAF IN 2014 along with magazine (2) 6(six) nos. of 9mm live rounds (3) 1(one) no. of SLR bearing registration number R6917 Butt No. 35 along with 7(seven) magazine, (4) 1(one) No. of HE(High Explosive) Hand Grenade and (5) 2(two) Nos. of Tube Launcher from the spot at 1:10 pm. And further seized the aforesaid articles at 01:30 pm by observing necessary formalities. The massive searched Operation was conducted from 11:30 am to 02:00 pm on the same day.

So it is therefore, handed over the seized articles to you for your kind consideration and further necessary action.
