Subject : Report.

Sir,

With due regards, I beg to state that today on 25/10/2023 at @ 12:30 am received information from own source that some unknown armed miscreant are trying to conceal and store arms, ammunition, explosive and other war-like items in the foothill and peripheral areas of the said villages i.e. Salam Patong, Phanjangkhong and Chandrakhong.

On receipt of the information, Cordon and Search Operation (CASO) has been conducted at the afore said villages along with three column of 33 AR and A/182 Bn BSF led by Shri Themthing Ngashangva IPS, IGP(Zone-I) assisted by Shri Sachidananda Soibam MPS, SP/TBL, Addl SPs (L&O)/(Ops)/TBL, OC/CDO-TBL, OC/NSK-PS, OC/Special CDO and a team of YPK-PS including women personnel and rushed to the spots immediately and launched a massive operation at 02:30 am by using metal detectors. On searching and found the undernoted articles i.e. (1) 2 (two) nos. of SLR bearing regd. numbers i.e. i) V6941 and ii) S5426, (2) 1(one) no. of INSAS Rifle bearing regd. no. 18407187, (3) 1(one) no. of 40 mm Lathode Gun bearing regd. No. CM/B5202138 RART-1, (4) 3(three) nos. of country made 9 mm Pistol along with one magazine, (5) 7(seven) nos. of 36 HE Hand Grenades along with 1(one) Detonator, 6) 1(one) no. of Chinese Hand Grenade, 7) 1 (one) no. of 40 mm Lathode Shell, 8) 1 (one) no. of Smoke Grenade, 9) 1(one) no. of Stun Grenade, 10) 1 (one) no. of Handheld Radio Set, 11) 1 (one) no. of INSAS magazine, 12) 2 (two) nos. of INSAS LMG magazine, 13) 25 (twenty-five) nos. of SLR magazine, 14) 2 (two) nos. of BP Plate along with 1 (one) no. of BP cover, 15) 3 (three) nos. of 7.62 mm live rounds, 16) 6 (six) nos. of 7.62 mm x 39 mm live rds, 17) 2 (two) nos. of 5.56mm live rds, 18) 13 (thirteen) nos. of Blank Cartridge and 19) 6 (six) nos. of .303 live rds. from the spot i.e in the jungle of Salam Patong at 5:10 am. And further seized the aforesaid articles at 05:40 am by observing necessary formalities. The massive searched Operation was conducted from 02:30 am to 06:00 am on the same day.

So it is therefore, handed over the seized articles to you for your kind consideration and further necessary action.
