



SUB: LODGING FIRST INFORMATION REPORT

R/SIR,



It is to inform you that on dated 27/09/2023 at about 1045 Hrs approx 2500 people of Thoubal district gathered near the gate of the DC office Thoubal. One representative from among that crowd enter inside the gate to deposit a Memorandum in connection with killing of 02 Meitai students and put demand to DC office at about 27/1140 Hrs. That representative went outside of the DC office. After that the crowd converted into mob and started stones pelting on security forces and Local police staff. After that stones pelting volume is very heavy and also use bottle petrol bombs, Gulel and empty beer bottles. They also burning tyres near the gate at about 27/1210 Hrs. Situation was out of control and also that aggressive mob trying to enter inside the gate forcefully and also that moving towards other gate of the DC office to enter forcefully.

In view of above, situation and sensing danger on troops and Govt. property QRT existing 01 Officer, 06 SO's and 24 ORS Total 31 Person of "B" coy EX 96 Bn BSF under Adhoc M and C- III Bn BSF which was deployed near the gate of dc office when situation was very tense and mob has very aggressive and continuously pelted stones ,petrol bombs gulel and empty beer bottles thrown over troops.

Therefore, after written order of Executive Magistrate Sh SB Telkhomba Yenghom, Thoubal to disperse the unlawful assembly (mob) "B" Coy Ex 96 Bn BSF under Adhoc M and C- III Bn BSF. Initially thrown 05 stun grenades ,fired 10 tear smoke munitions . But mob got more aggressive and not pay any heed on our verbal warning.

Therefore, we fired 66 Rds of 5.56 mm insas Rifle one by one in the air. After that mob was dispersed at about 27/1555 hrs after all coordinated efforts during this incident 01 Officers and 03 Or's got injured and not reported from mob side. Detail of fired persons:-
