SUB:-LODGING OF FIRST INFORMATION REPORT



Respected Sir,

It is to inform you that "A" Company 99 Bn BSF as a part of Adhoc KS- 12 Bn BSF is currently deployed at DC office, Thoubal (Manipur). On dated 27.09.2023 at about 0940 hrs SH Jasjit Singh, AC Coy Comdr of 'B' Coy 96 BN BSF telephonically informed undersigned for sending of one QRT team on gate of DC Thoubal office as civilians was gathering near main gate of DC office Thoubal for protest of alleged killing of two meitei students by Kuki militants. SI Vijay Kumar Banjara along with 02 SOs and 12 Ors total 15 Persons immediately reached on main gate of DC office Thoubal for crowd controlling and 2nd QRT consisting of Sh Ranjeet Kumar Das, AC along with 02 SOs and 13 ORs total 16 Pers also reached on the spot. At about 1030 Hrs a crowd of civilians mostly students gathered outside of main gate of DC Office Thoubal and gathering was slowly increasing on gate approx 2000 to 2500 including boys and girls. At about 1140 Hrs crowd converted into un-lawful assembly (MOB) and started pelting stones on security forces and police staff. After that stone pelting volume become very heavy and MOB was also using bottle petrol bomb, Gulel and empty beer bottles on SFS and police staffs. At about 1210 Hrs, the situation become very critical and MOB started move towards the own parties inside the DC office Thoubal. After giving permission by SH Telkhomba Yengkhom executive magistrate Thoubal and as per direction of SH Sachidananda Soibam, SP Thoubal to disperse the un-lawful assembly (MOB), our party used dye marker grenade to disperse the MOB but MOB was still moving towards the own parties.

insing danger of life of own troops and govt property, SI Vijay Kumar Banjara fired 11 rounds in regular intervals in the air in safe direction to disperse the MOB (Type of Weapon-AK 47 Butt No.-127 body No.8902-6150, type of Amn-7.62 MM). No any casualty and damaged occurred to any civilians. At about 1240 Hrs MOB got calm down for few minutes and at about 1300 Hrs MOB again become aggressive and started pelting stone on SFS and police staffs. After few minutes MOB again become calm down and started argue with SP Thoubal and police staff. At about 1530 hrs crowd gradually dispersed.

02. After thoroughly checking of our troops and control items, the details are as follow:-

- (i) 11 Rds of 7.62 MM fired by SI(GD) Vijay Kumar Banjara
- (ii) Hc(GD) D.D Biswas fired 01 dye marker grenade.
- (iii) CT(GD) Manoj Singh fired 01 dye marker grenade.

03. Details of injuries of our parties are as under:-

- (i) HC(GD) Vinod Kumar hit by stone on face near nose.
- (ii) HC(GD) Ram Awadh Singh hit by stone on left eyebrow and got cut. Three stitches have given to him on his left eyebrow.
- (iii) HC(GD) Sahdev Das hit by stone on right leg.
- (iv) CT(GD) Ravi S.S. hit by stone on right leg.
- (v) CT(GD) Manoj Singh hit by stone lower back. First aid provided. Situation is now under control and crowd almost dispersed at about 1600 hrs

04. It is requested that an FIR be lodged and provide us three copies of it for official purpose and record please.
