I have the honour to report that on 13/10/2023 at 6:10 pm, my aunt name, ~~Yumnam Tombimacha Devi~~ Yumnam Tombimacha Devi aged about 60 yrs w/p Y. Manihar Singh of Lamding Mamang Leikai was knocked down by one over speeding unknown two wheeler vehicle on the way while she was returning home by foot at Wangjing Heirok crossing along NH102 due to rash or negligent riding on the part of unknown rider of the said vehicle. The said vehicle proceeded towards Khongjom side leaving the scene in high speed.
