

Today, i.e. 17/10/2023 at 1:40 pm, received an information that on the same day at about 1:30 pm, one Tata INTRA V20 bearing regd. no. MN04A2731 driven by unknown person which was proceeding from Imphal towards Wangjing side along NH102 met a road traffic accident with one motorcycle KTM DUKE 200 bearing regd. no. NIL ridden by unknown person which was proceeding in the same direction at Khangabok in front of MMRC Park due to rash or negligent driving/riding on the part of both driver and rider. As a result of it, rider of the KTM DUKE 200 and its one unknown pillion rider sustained injuries on their persons and evacuated to the hospital for medical treatment. The Tata INTRA V20 bearing regd. no. MN04A2731 was partly damaged and the KTM DUKE 200 bearing regd. no. NIL was also damaged.

Hence, a suo-motu case FIR No. 180(10)2023 TBL-PS u/s 279/338/427 IPC has been registered for investigation.
