

Sir,

I have the honour to report that on 18/10/2023 9:30 am, one of my staff informed that the collapsible door lock (main door) of PHC, Leishangthem was found broken. On further checking the rooms along with my staffs, the following items kept inside the PHC rooms were found missing:

- (1) 1 (one) cooking gas cylinder worth Rs. 3500 (approx.)
- (2) 3 (three) numbers of EXIDE Solatubular Battery 12 V worth Rs. 55,500 (approx.)
- (3) 20 (twenty) numbers of spectacles worth Rs. 30,000 (approx.)
- (4) 1 (one) ENT set worth Rs. 2500 (approx.)

It is pertinent to mention that the abovementioned items might be stolen away by some unknown persons from inside the PHC rooms after breaking the door lock in the intervening night of 17/10/2023 and 18/10/2023.

It is therefore, requested to take necessary legal action in this regard.
