Today i.e. 24/10/2023 at 5.16 pm, received an information that on the same day at around 5.10 pm one Diesel Auto bearing regd. No.MN04D-1759 driven by unknown driver which was heading from Thoubal side towards Khongjom side dashed to a Tata Truck bearing regd. No.MN03T-1085 which was kept parked on the road side along the NH-102 adjacent to the gate of one Sanasam Shama Devi of Wangjing bazar due to rash & negligent driving. As a result of which, two unknown female occupants of the Diesel Auto were reportedly succumbed to their injuries at the spot. The driver and some other occupants got injured and evacuated to District Hospital Thoubal. The driver of the Diesel Auto was further referred to higher hospital from District Hospital, Thoubal. The Diesel Auto was damaged beyond repair, whereas the said Tata Truck was partly damaged.

Hence, a suo-motu case under FIR No. 182(10)2023 TBL-PS U/s 279/338/427/304-A IPC has been registered for investigation.
