On 21-08-2023 at about 7.30 am at the street of Complainant under the jurisdiction of Yairipok- P.S. and this Hon'ble Court.

Most Respectfully Sheweth:-

1. That, the Complainant is the law abiding bonafide citizen of India and a permanent resident of Yairipok Bishnunaha Awang Leikai, P.O. & P.S. Yairipok, Dist. Thoubal, Manipur. The Complainant and Accused persons are known to each other as they are neighbor.
2. That, the Accused persons are also a permanent resident of Yairipok Bishnunaha Awang Leikai, P.O. & P.S. Yairipok, Dist. Thoubal, Manipur. The Accused No. 2 and 3 are the son of the Accused No. 1.
3. That, the Complainant is the brother of Laishram Romita Devi aged about 44 years, W/o. Huidrom Tomba Singh of Thoubal Haokha Maning Leikai, P.O. & P.S. Thoubal, Dist. Thoubal, and Manipur and Laishram Anita Devi aged about 48 years, W/o. (L) Wahengbam Yaima Singh a resident of Yairipok Bishnunaha Awang Leikai, P.O. Thoubal, P.S. Yairipok, Dist. Thoubal, Manipur.
4. That, Wahengbam Abethoi Devi aged about 28 years, D/o. (L) W. Yaima Singh is the daughter of Laishram Anita Devi. And Laishram-

- Alex Meitei aged about 15 years is Complainant's son. The sister of Complainant namely L. Romita Devi is stayed at the house of Complainant for look after her minor son by the family member of the Complainant. The Complainant's sister namely Laishram Anita Devi and her daughter namely W. Abethoi Devi are also stayed at his home after the expiry of her husband.

5. That, on 21/08/2023 @ 7. 30 am the Complainant's two elder sister namely L. Romita Devi, L. Anita Devi and his niece namely W. Abethoi Devi and his son L. Alex Meitei were beaten black and blue causing grievous hurt on their bodies, attempted to murder, outraged their modesty by using deadly weapons likes stone, stick, dagger etc., at the street of Complainant's house by the Accused persons mentioned above namely i) Laishram Rupachandra Singh aged about 54 years, S/o. (L) L. Kunjabir Singh, ii) Laishram Ajit Singh aged about 32 years, S/o. L. Rupachandra Singh and iii) Laishram Bolu Singh aged about 20 years, S/o. L. Rupachandra Singh. Thereafter the victim persons are hospitalized for their medical treatment. (Enclosed herewith the medical papers and photos of injury in person for reference).
6. That, on 22/08/ 2023 a complaint/ report was made before the O/C, Yairipok Police Station to take up necessary legal actions against the accused persons but no actions is taken up till date. (Enclosed the application dt. 22/08/2023 filed before the O/C Yairipok P/S for reference).
7. That, thereafter, on 25<sup>th</sup> Sept., 2023, the Complainant filed the-

- complaint/ report before the S.P. Thoubal, Thoubal District, Manipur against the Accused persons. But till date no legal actions were taken against the Accused persons. (Enclosed herewith the copies of report dt. 25/09/2023 for reference).

8. That, with the facts and circumstances of the case the Accused persons have committed the offences mentioned in the application.

In the facts, reasons and circumstances it is therefore prayed that your Honour be please to take cognizance against the Accused persons, issued W/A and punish them according to law couple with a prayer for passing an appropriate order as deem fit for investigation for the ends of justice.


