Sir,


I beg to state that today i.e. 09/10/2023 at about 12 noon received a reliable information that some unknown armed miscreants have hidden some arms, ammunitions and explosives at Yairipok Gwarok Hill for using offensive act against State Security Forces and CAPF.

On receipt of the information, Special Operation Group (SOG) Thoubal District Police along with COB Thoubal, 33 AR, BSF C-Coy 195 Bn. Camp Yairipok led by Addl. SP(Ops), TBL assisted by OC CDO/TBL and one team of Yairipok PS under the supervision of SP/Thoubal have rushed to the spot immediately and launched a massive operation at 01:00 pm by using metal detectors. On searching and found the undernoted articles i.e. (1) 1 (one) no. of SLR bearing No. ED-6370 (2) 08 (eight) nos. of SLR magazines and (3) 1(one) no. 36 HE (High Explosive) Hand Grenade without detonator from the spot i.e. Yairipok Gwarok Hill at 02:00 pm.

Further, seized the aforesaid articles at 02:30 pm by observing necessary formalities. The massive searched operation was conducted from 01:00 pm to 02:40 pm of the same day.

It is therefore, handed over the seized articles to you for taking further necessary action.


