Today i.e. 27/09/2023 at around 02.30 pm, an unruly violent mob numbering about 8000 (eight thousand) including both male and female coming from different directions gathered at BJP Office Thoubal District, Khongjom, Manipur, and started rioting, using deathly weapons which are like axes, spades, big hammers, daggers, daos, stones, bricks, catapults etc. then they tried to open the BJP Office gate forcibly using the deathly weapons and also pelted stones and bricks heavily along with numerous catapults shots to the police personnel and 128 Bn. CRPF C-Coy deployed at BJP Office, from all the outside four surroundings of the BJP Office campus. In that a team of Khongjom P.S. led by myself, along with 02 (two) team of CDO/TBL Golf 42- led by S.I. L. Dhanabir Singh and Golf-55 led by Hav. Wilson, a team of Khongjom IB post led by S.I. Y. Shankardas Singh, and 128 Battalion CRPF C-Coy, which were already deployed in this PS and BJP office, jointly put great effort to control and disperse the violent unruly mob by firing many rounds of Tear Smoke Shells, Smoke Grenades, many live rounds of different ammunitions etc. in the open air to disperse the unruly mob. However the unruly mob were so violent and fierce that they obstructed the security personnel from discharging duties and over powered the security personnel and they even try to snatch weapons from the CDO Teams and from among the unruly fierce mob some live ammunitions were also fired out using unauthorised fired arms and also dismantled the wall's and pillars of ground floor, then they started burning the Office building. In the meantime the teams of fire tender and reinforce security personnel were also informed immediately through the District Police Control Room Thoubal (Golf-21) to control the fire, and dispersed the unruly mob, but the teams of fire tender and reinforce security team could not reach the spot timely as obstructed and blocked at several points by the violent unruly mob along the NH No. 102. So the building was badly set ablaze. Further the violent mob continued to dismantle the pillars and walls of the ground floor of the building by using heavy hammers and 1 (one) excavator (JCB) which was suspected to be detained by the unruly mob while travelling along NH No.-102. Immediately, our teams again started to dispersed the unruly mob with hard effort and during the time the excavator (JCB) escaped from the spot.

Further, the shifted position security personnel due to the violent unruly mob took safety position at the Khongjom PS campus, then the unruly violent mob again stormed at

Khongjom PS and obstructed the security personnel to proceed towards the place of occurrence. Later on at around 05.40 pm of the same day, 04 (four) re-inforce teams of CDO Kakching District, viz Golf- 83 led by Jam. E. Subash Singh, Golf-84 led by Hav. Ksh. Shantikumar Singh, Golf-61 Mobile led by HC. Kh. Robindro Singh and Golf-73 Mobile led by HC N. Bidyamanda Singh, rushed at Khongjom PS and jointly dispersed the unruly violent by firing many rounds of Tear Smoke Shells, Smoke Grenades, many live rounds of different ammunitions etc. in the open air. Then the unruly mob gradually dispersed one after another and totally disappeared. The incident last till 06.20 pm of the same day.

During the incident 03 (three) personnel of 128 Bn. CRPF C-Coy deployed at BJP Office namely (i) Force No. 1153437 SI/GD Md. Mujibur Rahaman (ii) Force No. 175023308 CT/GD Ram Singh Yadav & (iii) Force No. 034050392 HC/RO Gopinath Saha sustained injuries on their persons and evacuated to District Hospital, Thoubal, for medical treatment. Further the front glass of the Gypsy for Golf-55 and the left side window glass of the Gypsy for Golf-12 were totally damaged. The approximate value of the damaged building in the incident is about Rs. 70, 00,000/- (seventy lakhs).

Hence, a regular suo-moto case under FIR No. 52(09)2023 KJM-PS U/s 147/148/149/353/454/384/326/436/427/506/34 IPC & 25(1-C) A. Act has been registered for investigation.
