Sir,

I, the undersigned would like to bring forth to your knowledge and report that I, am a permanent residents and native of Hita Heng-jot (Shop Location: Dewlah lane, Imphal) P.O.&P.S. Sargai Kot District CCpur Manipur, belonging to Kuki tribe/community, recognized under the constitution of India. Thereby, I am entitled to the protection provided under The Prevention of Scheduled caste/ Scheduled Tribe Attrocities Act.

Due, to the ethnic conflict prevalent in the State, some unknown well-armed radicals belonging to the Meetei/Meitei community, aided by State's Forces posted at various Valley-based Police outpost chanting anti Tribal Slogans on 4th May 11 Noon looted, vandalized, burnt/gutted my shop and all what is within the shop and its premise, owned and under my proprietorship, a total estimated amount of Rs 17 Lacs was lost due to the illegal activities of the said armed-radical groups.

I, therefore kindly request you to please take action in this matter and come up with positive solution.
