Due, to the ethnic conflict prevalent in the State, some unknown well-armed radicals belonging to the Meetei/Meitei community, aided by State's Forces posted at various Valleybased Police outpost chanting anti Tribal Slogans on & Hth May 11 Noom, looted, vandalized, burnt/gutted my shop and all what is within the shop and its premise, owned and under my proprietorship, a total estimated amount of Rs . 1 1 lecswas lost due to the illegal activities of the said armed-radical groups.

I, therefore kindly request you to please take action in this matter and come up with positive solution.
