That I Jamkholet Haokip aged about 54 years S/o (L) Semkhothang Haokip Belonging to the Kuki Tribe / Community, a schedule Tribe recognized under the constitution of India, by virtue of which I am being entitled to the protection under The SC/ST (Prevention of Atrocities) Act, 1989, and that I am a permanent resident of Cannan Veng North AOC Imphal East 795001
- 2. That at about 8 pm on the 15th may 2023, a huge contingent of armed radical meeitei/Meitei suspected to be members of the Arambai Tengol and Meetei Leepun attacked our locality and in the process, they have looted and vandalized my house as well as my store room at Cannan Veng and also my book store which was located infront of KBC office Deulahland opposite DM College science gate.
- 3. That, it may be reported here that the above said criminal activities have caused grave mental agony and incurred huge loss which may be estimated to be Rs. 7580000 (Rupees seventy five lakhs eighty thousand) only
- 4. Fortunately, me and my family managed to escaped from the criminals who even tried to kill us, and now currently taking refuge at S Theimol Village Churachandpur.
- 5. That, I am filing this information lately because there is a great danger to my life and due to which I was at different places to save my life and now I am able to restore my health and settled at

 And thus I am filing the report lately today.

In the given circumstances, I humbly pray you kindly register an FIR/ZERO FIR, investigate the matter and punish the perpetrators as per the prevailing provisions of the laws of our country. And, for which act of kindness, I shall always remain thankful to you and obliged.
