it is to hereby inform that I, Mutum Sunil Singh S/o Mutum Bahadur Singh, inhabitant of DMC Road, Kabo .eikai (W), Thangmeiband, would like to draw your attention towards repeated thefts happening in our neighborhood since the past few months. 5 bicycles (4 new and 1 used) kept chained and locked, 2 water pumps (both fixed and bolted on platforms - Make Taxmo 1 HP green color and the other Crompton Minimaster 1.5 HP blue and red color), household items kept for sale etc.; Rough estimate for the items stolen would be around INR 98,000/-.
