Subject: Threat report

Sir,

This is to inform that one unknown person identifying himself as a member of underground outfit PLA has been sending msg and making calls on account of monetary demands to free soldier store located at uripok haobam dewan leikai which is run and managed by my elder brother namely Kh. Robin singh and the shop is also registered in his name. However, as a family member I have been assisting him in the shop. That yesterday ie, 21aug2023 calls has been made and msg has been sent to my personal mobile no. 7005646302 from two different nos- ie, 8257917255 and 8798302729 regarding the same monetary demand. That when I identified myself as a police officer they replied that they don't care for any state police as the work and courage of the police are confined only in the valley areas. That as I have ignored the msgs and the calls, several msgs has been sent stating that they will attack me, the store by planting bombs and kidnapped the staffs for ignoring their demands and given a dateline of today ie, 22nd aug 2023. It is a serious matter of concern that they have directly threatened a police officer belonging to the Manipur state police for monetary demands in the name of ug outfit. So, I would request sir to kindly take up necessary actions for avoiding any untoward incidents and find out the culprits as both the phone no.s are still active.


